**“LUL Method”** means any method of making thin films of tin oxide or lead oxide using a Licensed Product, the practice of which is covered by a Valid Claim in the country in which such method is practiced.

By purchasing the Product from Strem Chemicals, Inc. (“Strem Chemicals”) or one of its authorized distributors, Strem Chemicals grants to you, the purchaser of the Licensed Product (“Purchaser”), a non-transferable license under the Harvard IP (a) to the extent that the use of the Licensed Product is covered by the Harvard IP, to use the Licensed Product and practice LUL Methods solely (i) in internal, non-clinical research or (ii) if you are a company primarily in the business of performing research services, in Contract Research (as defined below) and (b) to practice the methods and processes claimed in the Harvard IP solely in conjunction with your use of the Licensed Product and solely in internal, non-clinical research.
